The Parish Council had earmarked £10,000.00 for the renewal of the playground equipment in the Grace Upward playground and also concluded it needed to maintain reserves to cover any costs as a result of the passing on of responsibilities for road maintenance by Highways. Accordingly whilst the Parish Council did not raise the precept it did not lower it.

Whilst the Parish Council had reviewed the amount of the reserves in January 2017 it was anticipated that that the reserves would be reduced by the end of the year down to approximately £20,000. However whilst the Parish Council purchased new equipment for the Grace Upward Play Area other items within its budget were significantly less than anticipated. The Parish Council had allowed:

- £2000 for street/cleaning highway maintenance which was not spent.
- A contingency for projects of £1000 of which only £373.80 was spent
- . £1500 for grants of which only £900 was spent

The Parish Council also received a grant of £1000 towards the cost of the play equipment. Therefore whilst the Parish Council considered that the cost of the Play Equipment would reduce the reserves to around £20,000. This did not happen.
